After completing the application and submitting the \$40.00 non-refundable application fee, Relocity Real Estate will process the application. You will be notified when you have been approved or declined. Typically, this process takes 1 to 2 business days.

Upon notification that your application has been approved, the security deposit and first month's rent will be due and payable in full, by certified funds. We will continue to market the property until the lease is signed and the security deposit is received. Properties will not be held in excess of two weeks.

Relocity Real Estate does not discriminate on the basis of race, color, sex, religion, national origin, handicap, or familial status.

A rental application must be completed by every applicant and occupant who is over the age of 18 (each must have a state-issued driver's license or state identification card). We reserve the right to discontinue the verification process of an application once negative information is found either on the credit & background report, or through other references given by the applicant.

What We Look for in an Applicant

Residency

A minimum of two years good residential rental history is required.

Employment

You must be currently employed and/or provide additional source(s) of verifiable income that meet property income requirements. Total household income must exceed three times the monthly lease rate.

Credit

Your credit report will be reviewed, any outstanding residential debt is unacceptable. Applicants with evictions or property collections will be declined. Please be aware that if your credit score is less than 600, you must have a perfect rental history. Foreclosure & bankruptcy will be looked at on a case-by-case basis.

Criminal History

Relocity Real Estate will reject applicants with any felony convictions, adjudicated verdicts, firearm charges, or crimes against persons or property. This applies to all residents and occupants. (As defined in Chapter 481.000 of the State of Texas Health and Safety Code).

Approval
